Medical facilities and reimbursement

1 Eligibility for Medical Attendance and Treatment

- 1.1 Staff members of the Institute as well as their family members shall be entitled to Medical Attendance and Treatment, including Reimbursement, as per procedures accorded by the Board of Governors from time to time (Item 1.1, [1]).
- 1.2 The provisions contained in this schedule shall apply to all the employees of the Institute except
 - a) retired members of staff
 - b) project staff. However, project staff shall be entitled only to OPD treatment at ODF Hospital/Institute's Hospital and cost of medicines not provided by ODF/Institute Hospital will also be reimbursable.
 - c) any employee/staff employed through contractors or on daily wage
- 1.3 The term "family" shall include (i) wife or husband of a member of staff, as the case may be, (ii) parents, children and step children who have been declared as wholly dependent on the member of staff (Item 1.2, [1]).
- 1.4 For purposes of reimbursement of medical expenses, members of the staff shall be grouped as under

Those holding posts carrying PB 3, and PB 4 with grade pay

Group A

Rs. 5400/- and above

Those holding posts carrying PB 2 with grade pay above Rs. Group B 4200/- but less than Rs. 5400/-

Those holding posts carrying PB 1 with grade pay less than Group C Rs. 4200/-

- 1.5 For the purposes of determining dependency, the following criteria shall be followed (Items 1.3 1.6, [1]):
 - Son A son shall be considered dependent till he starts earning or attains the age of 25 years or gets married, whichever is earlier,
 - Daughter A daughter shall be considered dependent till she starts earning or gets married whichever is earlier, irrespective of her age.
 - Parents Parents shall be considered dependent if their income from all sources, including pension, does not exceed Rs. 3500/- plus amount of the dearness relief on the basic pension of Rs.3500/- as on the date of consideration. For eligibility for Institute's medical facilities, the parents should reside with the staff member.
 - Economically Independent parents Parents who are economically independent but are
 physically staying with the staff shall be permitted to have Medical Consultation only at ODF
 Hospital at a nominal charge @ Rs.50/- per visit towards consultation charges; cost of
 medicines will be fully borne by the staff member. In such a case the concerned staff will be
 required to give an undertaking at ODF Hospital and the amount will be deducted from
 his/her salary.
 - Any other dependent (s) also entitled as per Government norms [2,3].
- 1.6 If both, husband and wife are employed in the Institute, medical facilities may be availed on behalf of self and dependents of either or both, by declaring the fact, through a joint declaration.
- 1.7 If the spouse of a staff member is employed in a State/Central Government/another Autonomous/Corporate body, the staff member can choose to claim the medical facilities either from the Institute or from the spouse's employer by declaring the same through a joint declaration.

2. Medical Record and Booklet [1, 4]

- 2.1 The Institute shall issue Medical Booklets to the staff member and his/her eligible family members with all the relevant information including a photograph. The system of affixing photograph of the beneficiary on the medical booklet must be strictly followed. Separate booklets in different colors would continue to be issued for staff and their families. The Medical Booklets will be renewed/ revalidated/replaced as per rules prescribed by the Institute from time to time.
- 2.2 Treatment facilities for dependents will be allowed only on the basis of valid booklets which have been renewed/ revalidated. The eligible persons desirous of availing the medical attendance and treatment shall be required to produce their Medical Booklet at the Health Center.
- 2.3 The medical booklets, also maintained as electronic booklets, should present the medical history of the holder.
- 2.4 The booklets must be surrendered when a staff leaves the Institute.

3. Medical Reimbursement Rules [1,4]

3.1 General reimbursement rules

- For reimbursement of both OPD and indoor treatment, the patient has to first consult an authorized medical attendant (AMA). The list of institute recognized AMA is given Annexure A. Patients are supposed to carry their medical booklet during their visit to the AMA.
- Further specialist OPD/indoor treatment can be availed from any of the institute empanelled hospitals after obtaining necessary referral from the AMA. The list of empanelled hospitals is provided in Annexure B.
- Claims for reimbursement have to be examined and countersigned by the AMA.
- Consultation fee will be reimbursed at the rate of Rs.100 for non-specialists for each consultation and at the rate of Rs.500 for specialist for each consultation; or actual, whichever is less.
- After obtaining the referral, any additional diagnostic tests can be availed from any of the empanelled hospitals/diagnostic centers on the recommendation of the referred doctor.
- If the patient is too ill to travel to consult a specialist, the AMA can summon such specialist to attend upon the patient. The specialist summoned under this clause on production of a certificate in writing by the AMA shall be entitled to travelling allowance as per the institute rules for the journeys to and from the place where the patient resides.
- If the AMA is of the opinion that owing to the severity of the illness, a patient cannot be given treatment at an empanelled hospital, the patient is entitled for treatment at his residence on production of a certificate in writing by the AMA.
- For a daughter/son over the age of 18 years and for dependent parents, the concerned staff member must certify that he/she meets the dependency criteria stipulated by the institute, when filling for reimbursement.
- Pre- and post-natal treatment of a female staff or spouse of a male staff is reimbursable without referral of AMA if treatment is obtained in any of the recognized Women's Hospital. Such treatment is reimbursable if the treatment is taken in any other empanelled hospital, under referral of the AMA.
- Reimbursement of the cost of medicines of Indian systems of medicine and homoeopathy is also admissible.
- Pathological and diagnostic services must be obtained from institute empanelled hospitals and diagnostic centers as given Annexure B, under referral of the AMA.

- List of AMA and empanelled hospitals/diagnostic centers will be periodically revised by the Institute Medical Board.
- OPD/indoor treatment can be availed in any state or central government hospitals (see examples listed in Annexure C) without a referral from an AMA.
- In case of misuse of medical reimbursement facility, concerned staff member will be liable to disciplinary action.

3.2 Medical Claims which are Not Reimbursable[1]

- Medical treatment without prior referral from an AMA is not reimbursable except in case of a medical emergency, or for the above-mentioned exceptions.
- Medical treatment availed in a non-empanelled hospital is not reimbursable except in case of medical emergency.
- Medical emergency has to be certified by the attending doctor.
- Items, procedures and medical conditions listed in Annexure D are not reimbursable.
 Annexure D will be reviewed periodically by the medical board.

3.3 Reimbursable Medical Expenses against the OPD Treatment (Item 3.2, [1])

- The cost of consultation, diagnostics/investigations and medicines purchased from the market against the referral for the OPD treatment, when incurred as per rules, can be claimed by filling the *Medical Claim Form for the OPD Treatment* only.
- The reimbursement of admissible items in respect of OPD treatment will be made based on actuals, with 100% reimbursement upto CGHS rates, and 50% of the amount in excess.
- Proper break up of charges for various diagnostics/investigations, minor procedures etc. with original receipts must be provided along with the claim.
- For the reimbursement of eligible expenses, the claim form duly completed by the concerned staff member should be forwarded to Accounts Section.
- Prolonged treatment not requiring hospitalization may be defined as a case of single and continuous spell of illness. In such cases, upto (4) specialist OPD consultations over a maximum period of three (3) months is allowable before referral is again sought from AMA.
- In case of prolonged medical treatment, the validity of a prescription should not exceed a period of three (3) months
- The *Medical Claim Form for the OPD Treatment* along with the original receipts and photocopies of the prescriptions should be submitted within 90 days of treatment. Otherwise it will be considered to be time-barred and require special approval from the Director.

3.4 Reimbursable Medical Expenses against the Indoor Treatment [1][6]

• Charges against the Indoor Treatment including the hospital bills, stay charges, operation and allied charges, investigation charges, cost of medicines supplied by the hospital/purchased from market etc, when incurred as per rules, are reimbursable.

Admissible diagnostic tests and/or procedure/surgery in respect of indoor treatment are reimbursable 100% upto CGHS rates, and 50% of the amount in excess.

- . Such expenses can be claimed by filling the *Medical Claim Form for the Indoor Treatment* only.
- The entitlement for indoor treatment would be as per the following categories (Item 4.6, [1]):
 - Group C: General/Semi-private/Private Ward based on GOI norms;
 - Group B: Semi-Private/Private Ward based on GOI norms;
 - Group A: Private Ward;
- The form duly filled by the concerned staff member should be forwarded to Accounts Section.
- The Medical Claim Form for the Indoor Treatment along with the original receipts and photocopies of the prescriptions should be submitted to the CMO/Designate within 90 days of treatment. Otherwise it will be considered to be time-barred and would require special approval from the Director.
- In case of Indoor Treatment for major diseases, medical advance can be availed based on the estimation of hospital and on the recommendation of the AMA. Advance amount cannot exceed 90% [7] of the recommended amount. Advance will not be given after submission of medical reimbursement form.

3.5. Medical TA [7]

- Staff members and member of their families are entitled to T.A. for travel undertaken to avail
 Medical Attendance including admission in a recognized hospital as well as consultation with a
 Private specialist provided the journey is undertaken under the written advice of AMA and the
 journey is undertaken beyond 8 k.m. each way. T.A. for an escort will also be admissible in
 cases where it is certified by the AMA that the patient is not in a position to undertake the
 journey of his/her own
- The T.A. will be regulated as the T.A. Rules laid down by the Govt. of India from time to time, in addition to the provision contained in the Statue (Sch. AA). Medical T.A. claims should be preferred in the T.A. claim form and certified and countersigned by the Institute Medical Officer who referred the case to outside hospital/specialist. The entitlements for T.A. are as follows
 - o Basic pay Rs.6500/- and above Taxi/Bus/Railway (Ist class)
 - Basic pay Rs.6499/- and below Auto/Bus/Railway (IInd class)
- Ambulance when available is provided to transfer the patients admitted to IIT Hospital to
 outside hospitals. The Medical Officers/Sisters on duty will prepare the ambulance slip giving
 the particulars of the patients and the purpose of his/her visits etc
- However, patients who do not require ambulance but are sick enough not to travel by Public Transport and are also not entitled to avail Taxi-fare can claim for full reimbursement of Taxifare on recommendation of the referring A.M.A.

3.6. Medical TA [7]

 The cost of hearing aid procured under the advise of the ENT Specialist from recognized centres is met by the Institute by making direct payment to the centres. The rate of maximum ceiling has been fixed upto Rs.10,000/- for one side hearing aid and Rs.20,000/- for bilateral hearing aid and Rs.60,000/- under special circumstances as per the Government Orders.

4. Medical Facility for Students (Item 5, [1])

- 4.1. Basic Medical facilities for common diseases like fever, cold etc will be provided by the Institute through its doctor at the Institute Health Center. It will include providing medicines for the above mentioned diseases. In case Institute appointed doctor deems fit that the concerned patient needs to consult a specialist, the Institute shall reimburse doctor's fees only if the concerned doctor is on Institute's panel of selected doctors. If medicines prescribed by the specialist are not available at the Institute's dispensary their cost will be reimbursed at 80% of the total amount, including specialist doctor's fees.
- 4.2. Institute shall reimburse 100% costs for common pathological tests of blood, urine and stool. While for other tests only 50% of the cost shall be reimbursed.
- 4.3. In case institute doctor or a doctor on institute panel advises for tests like CAT-scan etc., then only 50% of the cost of such test shall be borne by the institute.
- 4.4. On Case to case basis a student may be given advance for medical treatment. This advance from Students' Benefit Account shall only be given to students who have weak financial background. The recovery of such advance will be done before completion of a students' programme.
- 4.5. In case, a student is injured while working in a lab, institute shall provide the best medical facility available in Hyderabad city subject to the maximum amount of Rs 50,000.
- 4.6. In case, a student is injured while representing institute in a cultural or a sports event, institute shall provide the best medical facility available in Hyderabad city subject to the maximum amount of Rs 25,000.
- 4.7. On the referral of the Authorized Medical Attendant /CMO of the Institute a patient should be referred to the Out-Patient Department (OPD) of Government/recognized hospitals/dispensary unless reference to a specialist is considered necessary and charged levied at OPD shall be reimbursable. Such medical claim should be countersigned by the AMA/CMO of the Institute.
- 4.8. When treatment of specialist Doctor is considered necessary it will be restricted to two consultations only within 5 days for single treatment. The medical claims should be countersigned by the AMA/CMO of the Institute. If medicines prescribed by specialist Doctor are not available at the Institute's dispensary, their cost will be reimbursed at 80% of the total amount including specialist Doctor's Fee. Prolonged medical attendance and treatment whether Outdoor or Indoor is not allowed for the students.
- 4.9. After completion of treatment from Institute's AMA/CMO, OPD, Specialist Doctor medical reimbursement bill should be submitted to the Institute for reimburse meant within 30 days and for indoor patient it should be submitted within 90 days otherwise it will be barred.
- 4.10. No reimbursement or medical claims will be entertained from students away from campus (leave/vacation).
- 4.11. Medical expenses of the students will be met from membership of SHMC fund.
- 4.12. For such treatment like Dental/Eye/Skin only the cost of medicine be allowed as per Institute norms.
- 4.13. In case of medicine purchased from outside Certification by Institute Doctor that the medicine was not available in the stock.
- 4.14. Spouse and kids of married students residing on campus shall be provided medical facility on payment basis (as fixed by Institute)
- 4.15. QIP Research Scholars are treated at par with the other students of this Institute. They are entitled to Medical attendance/treatment and reimbursement as other students, as stated in the previous paragraphs [8]
